Important Dates and Schedule of Reporting

The Christian Reformed Church in North America (CRCNA) is eager to partner with you in your administrative role. We reach out to you several times a year to provide you with updates on your ministry share and church offering gifts. We also provide you with a calendar outlining key dates in the ministry year and suggested dates for offerings.

July 2024

- The Denomination starts its new fiscal year.
- The Church Administration and Finance Guide booklet is distributed and posted online.
- Quarterly Church Giving Report is sent to churches (April, May June).
- CRCNA Offering Calendar and deacon's helper worksheet are distributed.

August 2024

• Yearbook Questionnaires are opened/sent to churches. This is due in October.

September 2024

- The Ministry Shares Program pledge season starts.
- Churches should begin having a conversation about their pledge amount for ministry shares. This pledge would be for the denomination's fiscal budget year July 1, 2025- June 30, 2026.*
- Information will be mailed to each church regarding the ministry shares pledge process as well as historical information on a church's giving to the ministry shares program.
- Classes have conversations about ministry shares at their fall meetings.
- Congregations are encouraged to have a pledge amount ready to report at their fall classis meeting.

October 2024

- Classis can begin to report pledges to the denomination through the online system.
- Quarterly Church Giving Report is sent to churches (July, August, September).
- Information will be sent to Classis Clerks and Treasurers regarding submitting pledges.
- Council of Delegates meets.
- Yearbook Questionnaire is due before the end of the month (October 15th).

December 2024

- The 2024 Annual Ministry Report is distributed through The Banner (copies can be requested or the report can be viewed online at crcna.org/MinistryReport).
- The denomination begins budget planning for the 2026 fiscal year (July 1, 2025 -June 30, 2026).

January 2025

• Quarterly Church Giving Report is sent to churches (October, November, December).

February 2025

- Pledges from all churches should be submitted to the classis and the denomination.**
- Council of Delegates meets (virtually).

March 2025

• March 15th Overtures and Communications are due for synod.

April 2025

- Quarterly Church Giving Report is sent to churches (January, February, March).
- Classis submit your financial review and internal controls for Directors and Operators Liability Insurance.

May 2025

- Council of Delegates meets.
- Allocation of ministry shares 2026 is approved by the corporations and the COD.
- The denominational budget is reviewed and approved by the corporations and Council of Delegates.

June 2025

• Synod 2025

* The denomination plans its budget on a July-June fiscal year. Churches may have a different timetable.

** New or revised ministry shares pledges are accepted at any time throughout the year.

From the congregational support ministries of Thrive, to the global reach of Resonate Global Mission and ReFrame Ministries, to the fostering of the next generation of ministry leaders at Calvin University and Calvin Theological Seminary, your invaluable support enables ministry to flourish.

This is why your church's pledge is so important. You make it possible for ministries to plan and carry out their work. We understand that our reminders to pledge may sometimes feel like a bother, but please know that they stem from the fundamental need to effectively budget for and steward these ministries. Your pledge ensures that we can effectively allocate resources and carry out important ministry.

I hope that your congregation will engage in thoughtful discussions about CRCNA ministries and will prayerfully discern what you can pledge for the coming fiscal year. Once you have discerned your financial commitment, kindly submit your congregational pledge to the treasurer of your classis between October 2024 and February 2025. If this does not fit with your budgetary cycle, please submit a 12-month pledge at a time that works for you and let us know what time frame your pledge represents. Please also include me in your correspondence.

Ministers' Pension

The CRCNA has defined benefit pension plans for ordained ministers of the Word serving in the United States and Canada. The primary features of the plans include four benefit groups:

- Retirement benefits commencing at age 66, or early retirement benefits in a reduced amount beginning at age 55.
- Long-term disability benefits provided through an insurance company.
- Survivors' benefits paid to a surviving spouse when death of a member occurs while in active service.
- Orphans' benefits paid to a member's orphaned children up to age 18, or to age 21 if in school.

To participate in the Ministers' Pension Plan (MPP), ordained pastors need to complete the MPP registration form and submit it to the pension office.

There are costs associated with participation in the Plan. Organized churches are expected to pay an amount determined on the basis of a per-member assessment amount multiplied by the number of professing members (or the annual direct cost of participation of their first/only pastor if that amount is greater). In addition, churches pay the direct costs associated with any additional ordained ministers in their employ. Emerging churches must pay the annual direct costs of their ordained pastors, but are not expected to pay based on per member assessments if they do not have an ordained Pastor.

Ministers' Compensation Survey 2024

In the past, detailed surveys were sent to churches and pastors to gather information on base salary, housing, benefits, and other elements for our Ministers Compensation Survey. However, the number of returned surveys decreased over time which affected the reliability of the data. To ensure we provide more accurate and valuable information to churches, we adopted a new approach.

We currently rely on information received from ministers of the Word who are participants in the Ministers' Pension Plans in the United States and Canada. This group represents the majority of active ministers in the CRCNA. Participants in the pension program are required to report their total base salary and housing or parsonage allowance annually. We have utilized this data to compile the information presented in the following pages.

Why is this new method better? Firstly, the response group is larger, providing more reliable insights. Secondly, using averages of components is more useful than simply summing up compensation. The housing allowance for each minister depends on personal circumstances and local economic factors, which can vary significantly across classes and geographic areas.

What information does the survey include? There are two charts for each country of service. One chart displays the average total salary for ministers in each classis, combining base salary and housing factors. The other chart shows the salary range in relation to percentiles marked at 10% intervals for all ministers in the respective country.

For example, salaries at the 10th percentile are equal to or greater than those of 10% of ministers, and lower than the salaries of 90% of ministers in the country. The 20th percentile represents salaries that are equal to or greater than those of 20% of ministers, and lower than those of 80% of ministers, and so on.

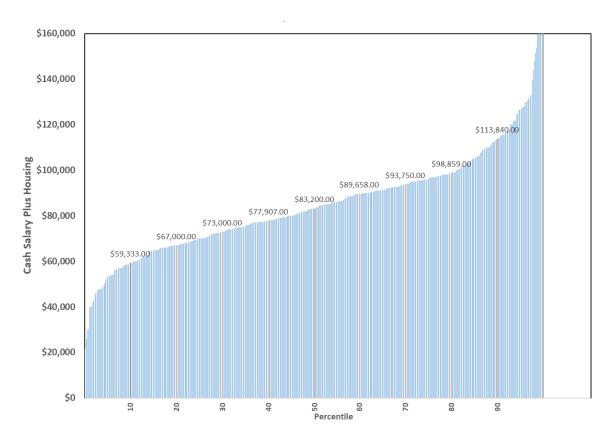

Note about Recommended Organizations

Synod 2023 adopted a motion to discontinue the practice and policy of reviewing and recommending charitable organizations to CRC churches for offerings. The Office of General Secretary provides the following guidelines to assist churches in their vetting process of charitable organizations being considered for offerings:

A. General Requirements

The organization must:

- have been in existence for a minimum of three years.
- be closely related to our integral work.
 - for the CRCNA that was: works of mercy, of Christian education, or the distribution of the Word of God.
 - This included affiliated colleges and universities (Dordt, King's, Redeemer, Trinity).
- be closely allied with our ecclesiastical mission.
- agree with the CRCNA's fundraising ethical guidelines.
- not compete directly with existing denominational ministries.
- **B.** Program Requirements
- A statement of the purpose along with clearly identified goals of the organization.
- Clearly outlined changes to purpose and goals if those have taken place in the last year.
- A statement describing new programs or changes in current programs.
- An explanation of programs the organization is no longer engaged in.

- Geographical area served.
- List of degree programs offered or soon to be offered (if applicable).
- Corporate bylaws, and/or changes to bylaws.
- C. Financial Requirements

To analyze the financial conditions of the various organizations asking for financial support, such organizations are to provide the following information:

- Federal Employer ID number in the US; Charity Registration Number in Canada.
- Most recent financial statement, audited or reviewed by a Certified Public Accountant or Chartered Accountant.
- Current and previous fiscal year's operating budget, including the percentage attributed to program and support expenditures.
- Statement of the amount of contributions received from Christian Reformed Church congregations and the percentage this represents of total contributions.
- Statement indicating a fidelity bond is in effect and the amount of that bond coverage.

- Financial analysis including, but not limited to, the following:
 - Days operations coverage = (cash + investments + other liquid current assets - current liabilities) / 250
 - Dollar and percent change in net assets from the prior year
- Percent overhead = (management and general + fund raising) / total expense
- Comparison of net asset levels over the prior three years
- Source of current assets during the prior three years

Special Assistance Fund

The Special Assistance Fund provides assistance for retired Ministers of the Word who find themselves in severe financial need and may also provide for the final retirement move of a Ministry of the Word.

403(b)(9) Retirement Income Plan

The CRCNA has a 403(b)(9) retirement plan in which all Christian Reformed Churches in the U.S. may participate. This Retirement Income Plan (RIP) has an advantage over regular 403(b) plans in that it allows ordained and commissioned pastors a housing allowance tax benefit when they begin distributions from the plan after retirement. The RIP is available for all church staff (including ministers of the Word who remain active participants in the denominational Ministers' Pension Plan).

All Christian Reformed Churches can adopt the "base" plan and then customize it into their own individual 403(b)(9) retirement program. This customization will include choosing the percent contributed by the church (a matching contribution and/or a base contribution) and who is eligible to participate.

The CRC's partner in this retirement program is Envoy Financial. Churches can go directly to the website (crcna-retirement.com) where they can download and fill out an inquiry form.
